#### 1. Introduction: Background of the ORD Action Plan

January 2020: The State Secretariat for Education, Research and

Innovation (SERI) mandates swissuniversities, the EPFL, ETHZ, and the SNSF to develop a Swiss

National Strategy for Open Research Data (ORD)

July 2021: The <u>Swiss National Strategy for Open Research Data</u>

(ORD) is published. It was developed in a joint

undertaking by swissuniversities, the ETH Domain, the SNSF, and the Swiss Academies of Arts and Sciences

January 2022: Publication of the associated ORD Action Plan which

concretises the measures of the ORD Strategy.

#### 1. Introduction: ORD Action Plan & Open Science I Programme

- swissuniversities' Programme Open Science I, Phase B ORD implements those action lines of the ORD Action Plan that are under the responsibility of swissuniversities and finances them through federal project contributions (PgB)
- The <u>Delegation Open Science</u> manages the implementation of the Open Science I Phase B – ORD Programme on behalf of the swissuniversities Board and is the decision-making body

#### ORD Action Plan: Primary Ownership and Funding Responsibility

- Each Measure details Actions Lines, for which primary owners have been identified amongst the key actors.
- The identified responsibility for funding of the Action Lines lies with designated key actors (swissuniversities, ETH Domain, SNSF or Academies).
- The Action Plan covers two ERI periods (2022-2028).
  - For the period 2022-2024, the plan uses existing or planned ORD funds, including funds of the PgB Open Science I Phase B – ORD
  - For the second ERI period 2025-2028, the Strategy Council will evaluate the financial needs and detail them in a version 2.0 of the Action Plan.

## Action Area A: Support researchers and research communities in imagining and adopting ORD practices

Measure A1: Provide bottom-up support to promote excellence in ORD practices

No.	Action lines	Primary ownership	Identified funding responsibility
A1.2.1	Provide ORD grants to (a) support and develop ORD practices that primarily benefit researchers, and (b) help researchers develop ORD practices	swissuniversities and ETH Domain	swissuniversities: PgB Open Science I, Phase B – ORD ETH Domain
A1.2.2	By extension, provide ORD grants to research communities in a community building and institution building approach	swissuniversities and ETH Domain	swissuniversities: PgB Open Science I, Phase B – ORD ETH Domain

#### **Action Area A: Swiss Open Research Data Grants**

- The collaborative programme between swissuniversities and the ETH Domain promotes coherent and broad, bottom-up support for ORD practices across disciplines and higher education institutions in Switzerland, thereby facilitating the creation of synergies and complementarities.
- Three Tracks
  - Track A: Explore projects
  - Track B: Establish projects
  - Track C: Contribute projects
- Matching funds principle and PgB-rules apply

#### Action Area A: Swiss Open Research Data Grants

#### Track A: Explore projects – deadline: 1 August 2022 (first call)

- Goal: Help researchers pursue pathways to determine if and how ORD practices can be developed. This track encompasses earlyphase exploration as well as the testing and prototyping of a potential ORD practice. It also allows for engagement with a community without necessarily creating a final product.
- Duration: up to 18 months
- <u>Budget:</u> the total cost of the project (including matching funds) must not exceed CHF 150,000

#### **Action Area A: Swiss Open Research Data Grants**

Track B: Establish projects – deadline: 1 July 2022 (pre-proposals)

- Goal: Track B supports the anchoring of existing ORD practices that have a research agenda and a common understanding of ORD principles. It provides the opportunity to take these practices to the next level, improve their scope, and develop projects that can become de facto standards in a community and promote quality.
- Duration: up to 24 months
- <u>Budget:</u> the total cost of the project (including matching funds) must not exceed CHF 1.5 million

#### **Action Area A: Swiss Open Research Data Grants**

## Track C: Contribute projects – deadline: 1 December 2022 (first call)

- Goal: this track enables researchers to contribute to existing open communities built on ORD principles, validate their integration into existing infrastructures (also on an international scale), and focus on their potential to improve scientific impact and technical quality.
- Duration: up to 12 months
- Budget: the total cost of the project (including matching funds) must not exceed CHF 30,000

#### **Call for HEIs Action Plans**

- All <u>eligible higher education institutions</u> (HEIs) are invited to describe their ideas and intentions for establishing data stewardship at their institution in the form of a (short) action plan.
  - ➤ It is important that the planned measures can be financially sustained by the HEI after the start-up funding by the Open Science Programme
- Collaborations with other eligible Swiss HEIs are welcome
- The decision-making body is the Delegation Open Science. In case of a positive decision, the available funds will be distributed on the basis of a distribution key
